The BetterMan Charitable Trust (**us, we, our**) is a registered charity with the Charities Commission (CC61904) and is incorporated under the Charitable Trusts Act 1957 (NZBN 9429051948344).

We have developed a donation policy as part of our commitment to honouring and respecting the financial contributions that people make to our cause. We recognise the importance of donations and want to ensure we establish appropriate principles of transparency and fairness in regard to the management of donations.

Charitable Purposes

(together, our **Charitable Purposes**).

Any funds raised from you for a specific purpose (as agreed with us) that have not been applied to fulfil that purpose may be refunded back to you.

The Board reserves the right to return funds received from any donor in cases where the Board considers, in its sole discretion, that acceptance of the funds or affiliation with the individual or donor organisation (as the case may be) will or might reasonably be expected to: (i) damage or prejudice or bring into disrepute our reputation or goodwill; or (ii) be inconsistent with our Charitable Purposes.
